**ORDER**

WHEREAS, Forbesganj College, Plot No.Kirkichia, Street No.By pass, Vill/Po-Forbesganj, Tehsil/Taluka-Forbesganj, City-Forbesganj, Dist-Araria, Bihar-854318 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order No.14753 dated 14.11.2012, followed by revised recognition order No.32655 dt.31.05.2015 with an intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, as per decision of the ERC taken in its 274<sup>th</sup> meeting held on 15<sup>th</sup> - 16<sup>th</sup> July, 2019, the recognition of the institution was withdrawn from the academic session 2020-2021. Accordingly, withdrawal order No.51348 dt.22.08.2019 was issued to the institution.

3. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the withdrawal order of ERC. The appellate authority vide order No.89-20/ E-150733/ 2020 Appeal/ 21<sup>st</sup> Mtg.-2020/ 7<sup>th</sup> September, 2020/ 94776 dt.04.11.2020 remanded back to the ERC with a direction to consider the documents submitted in appeal, to be sent to ERC by the appellant, and take further action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC, the documents submitted in appeal, with originals thereof, wherever necessary, within 15 days of receipt of orders on the appeal.

4. AND WHEREAS, the ERC in its 286<sup>th</sup> meeting held on 25<sup>th</sup> & 26<sup>th</sup> November, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 04.11.2020, and decided as under:-

Restoration of recognition order of B.Ed. course with an annual intake of 100 students (02 unit) be issued.

5. NOW THEREFORE, recognition withdrawn vide order dated 06.03.2020 to the institution viz. Forbesganj College, Plot No.Kirkichia, Street No.By pass, Vill/Po-Forbesganj, Tehsil/Taluka-Forbesganj, City-Forbesganj, Dist-Araria, Bihar-854318 for B.Ed. course is hereby restored.

**ORDER**

**WHEREAS**, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. **AND WHEREAS**, the institution viz. **Forbesganj College, Plot No. Kirkichia, Street No. By pass, Vill/Po- Forbesganj, Tehsil/Taluka-Forbesganj, City-Forbesganj, Dist.-Araria, Bihar-854318** was granted recognition as per Regulation 2009 for conduct of B.Ed. Course of **One year** duration with an annual intake of **100** from the academic session **2013-2014** vide ERC order No. **ERC/7-144.6.7/NCTE/B.Ed./2012/ 14753** dated **14.11.2012**.

3. **AND WHEREAS**, the institution viz. Forbesganj College, Plot No. Kirkichia, Street No. By pass, Vill/Po- Forbesganj, Tehsil/Taluka-Forbesganj, City-Forbesganj, Dist.-Araria, Bihar-854318 has by affidavit dated 02.02.2015 consented to come under New Regulations 2014 and sought for **Two Basic Units in B.Ed. course**, which require additional facilities.

4. **AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to fulfill following conditions namely,

- (i) The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committee with required documents by October 31, 2015.
- (ii) The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.

- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

5. **Now therefore**, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition to **Forbesganj College, Plot No. Kirkichia, Street No. By pass, Vill/Po- Forbesganj, Tehsil/Taluka-Forbesganj, City-Forbesganj, Dist.-Araria, Bihar-854318** for conducting B.Ed. Programme of **two years** duration with an annual intake of **100 for two basic units of 50 students each** from the academic session **2015-2016** subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter:
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. If it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
